Background checks are performed on all applicants volunteering with the Aurora Public Schools and will reveal any and all instances in which you may have been arrested, summoned, charged or convicted for minor (such as underage drinking, shoplifting, simple assault, motor vehicle violations, etc.) and major offenses, both locally and nationally. **If these types of things have occurred in your past, and you deny knowledge of such occurrences by answering "NO" to the applicable question(s), you may be disqualified from volunteering with the Aurora Public Schools for at least one year.** If you have had instances in the past, which would require a good faith answer of "Yes" to any of the following questions, this will not bar you from volunteer consideration; each case is judged individually and many offenses, particularly minor ones, may not prevent you from becoming a volunteer for the Aurora Public Schools.
